"The State has filed the present appeal challenging the order of the learned Single Judge in W.P. No. 103813/2021.

Learned Govt. Advocate submits that operative portion of the order at paragraph nos. (ii) to (v) and consequently paragraph no. (vi) is liable to be set aside as the reference by the learned Single Judge to the judgment in W.P. No. 18939/2009 and reliance was made without noticing that the very order has been stayed by the apex Court in Special Leave to Appeal Nos. 15837-15838/2016.

It is further pointed out that an order came to be passed in W.A. No. 3589/2019 directing that the authorities were bound to register the sale deed without insisting for production of '11E' sketch. As against the said order, the State had preferred SLP No. 12351/2021 wherein the operation of the impugned judgment in the Writ Appeal has been stayed. Accordingly, it is submitted that these facts have not been referred to by the learned Single Judge as a result of which impugned directions cannot be sustained. Accordingly, subject to further consideration taking note of the order passed by the apex Court staying the direction of the High Court dispensing with '11E' sketch, there would be an interim-order of stay of the order of the learned Single Judge. The order of stay is passed taking note of the urgency pleaded by the State and the implication of the direction and is passed pending consideration of I.A. No. 2/2021.

I.A. No. 1/2021 has been filed seeking dispensation of production of translated copies of Annexure-A which is in Kannada. In the light of the submission made, furnishing of English translation of Annexure-A is dispensed with for the present.
