- (2) If any partner is a minor, the fact whether he is entitled to the benefits of partnership should be set out herein.
- (3) For the registration of each firm a separate application is necessary. Accordingly the applicants should supply in this application only particulars of the firm in respect of which the application is made. - (9) This statement must be signed by all the partners or their agents specially authorised in this behalf in the presence of witnesses who must be Gazetted officer, Advocates, Magistrate, Notary public, attorney of High Court, Pleader, Charged Accountants, Restricted State Auditor, Sales Tax or Income Tax Act Practitioner.
